1. Introduction

This technical-scientific report meets the requirements set out in the Public Notice no. 247, August 19, 2022, Art. 13, comma 3, letter f), corresponding to promoting the exploitation of research results and ensuring open access to the public to research results and related data according to the principles of “Open science” and “FAIR Data”. It provides information on the Land-In-Pro literature collection which contains references to different kind of published sources, such as books, articles, official documents, etc., mainly concerning industrial heritage and landscapes studies. It is intended to be a living tool in which always new references can be added and made available as the research progresses on a finer level through the implementation of its recursive activities.

2. Land-In-Pro Literature Collection

The Land-In-Pro project is committed to identify, investigate, interpret, and assess (post)industrial landscapes and heritage as resources, critically unfolding new perspectives on conservation and adaptive reuse strategies. The literature collection is a formal output of the research activities envisaged in *Work Package 1 - Inventorying the tangible: investigating, identifying, and mapping* (WP1)¹. Land-In-Pro researchers collected a consisted corpus of references that provided the documentation-based groundwork on which study approaches, main research results and case studies, and possible on-going research improvements are identified in the field of heritage and landscape studies, with particular focus on those centred on (post)industrial legacy. Among those references, there is a series that largely pictures the state of the art around the Land-In-Pro selected territorial study context and the pilot (post)industrial site in the Liguria region.

2.1. Purposes of the Literature Collection

The objective of the Land-In-Pro Literature Collection is to establish a comprehensive list of scholarly references intended for scientific audiences such as scholars, researchers (all levels) and students involved in landscape and heritage studies and, architectural/urban planning studies, facilitating access to information regarding methodologies, principal research findings, case analyses, and potential advancements within the realm of heritage and landscape studies, with particular emphasis on industrial legacies. The corpus of this literature collection encompasses references of local, national, and with predominantly European relevance. The Land-In-Pro literature collection is intended to be a living tool in which always new references can be added and made available as the research progresses on a finer level through the implementation of its recursive activities.

The main characteristics of the Land-In-Pro Literature Collection are the following:

- It is **contributory to Land-In-Pro research objectives** and constitutes a documentation-based groundwork on which Land-In-Pro selected its territorial study context and pilot site within the Ligurian region.
- It is **centred on topics in the field of heritage and landscape studies**, with particular focus on those centred on industrial legacy.
- It is **accessible** to external stakeholders interested in Land-In-Pro research topics that can navigate it through the Land-In-Pro website.

- It is **periodically updated** with new references by Land-In-Pro researchers as the project progresses.

2.2. Methodology

The methodology used for collecting references called for a specific open source software allowing the Land-In-Pro researchers to collaborate in organising and structuring diverse published sources. To this end, Zotero is a reliable tool used by researchers to organise and export bibliographies. The workflow started with the implementation of complementary activities such as the collection of sources, their preliminary analysis, and the definition and following association of tags reflecting the project’s main topics.

The literature entries underwent classification via bibliographical information (author, year of publication, title, type of publication, publisher, etc.) alongside the assignment of tags aimed at clustering entries related to thematic contents in accordance with the issues and objectives underlined in the Land-In-Pro project. This classification process involved discerning tags associated with particular topics explored within the Land-In-Pro project.

On the Land-In-Pro website the literature collection is organised into a table and can be browsed according to the Land-In-Pro tags’ acronyms (See Table 2). In addition, if users are aware of specific references, they can browse the table also through author, publication year and type, and title.

If relevant to the Land-In-Pro objectives, those consulting the online bibliography, may suggest further references to be included in the Land-In-Pro literature collection by sending an email to landinpro@unige.it. Land-In-Pro researchers will evaluate the incorporation of the suggested source in the Land-In-Pro literature collection.

The updating of entries will be carried out periodically, as the Land-In-Pro research progresses.

2.3. Tools and cataloguing process

The use of Zotero² as collecting and cataloguing tool allowed the Land-In-Pro researchers to cooperate in an online environment and manage the amount of collected data in a systematic manner. This aspect was of pivotal importance to develop the literature collection activity in a collaborative way.

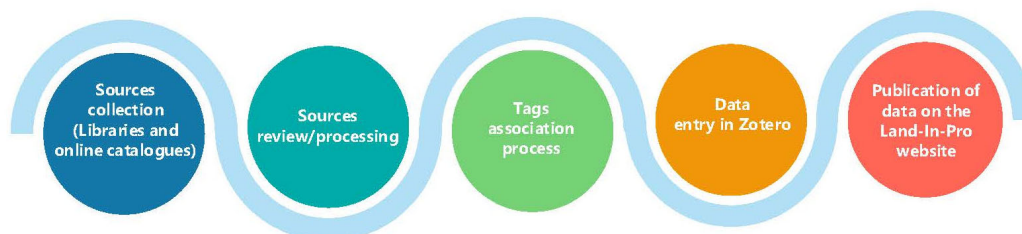


Figure 1 - Land-In-Pro literature collection workflow. © Land-In-Pro, 2022-2025.

The contributors to the literature collection are the Land-In-Pro researchers that established the workflow to follow in the gathering process (Fig. 1).

Literature sources were collected through the consultation of libraries’ online catalogues and by accessing to local libraries. Each published source was reviewed by researchers and tags were assigned. Following, each item underwent classification via bibliographical information input in Zotero.

The Zotero inputs (fields) taken into consideration are listed in the following Table 1.

2.4. Description of the tags system

Land-In-Pro researchers defined a tags system to cluster sources according to thematic contents in accordance with the issues and objectives underlined in the Land-In-Pro project.

Land-In-Pro researchers defined a tags system (Table 2) to cluster sources according to thematic contents in accordance with the issues and objectives underlined in the Land-In-Pro project. This system is composed of a series of main tags and sub-series of tags that relate to the main ones. Each main tag identifies a specific matter and the sub-tag further specify the item to which the main tag has been associated to. Hence, published sources can be identified as entries with one or more tag or sub-tag. Besides, a variable number of keywords are associated to each entry, in order to easily clarify the content of the published source.
